CHAPTER I

PERSONAL PROFESSORSHIP OF EMERGENCY MEDICINE

1. There is hereby established in the University the following Personal Professorship:

Personal Professorship of Emergency Medicine.

2. The holder of the foregoing Personal Professorship shall be required to be at the same time the holder in a permanent capacity of the office of Consultant of Emergency Medicine to be established in conjunction with the said Personal Professorship by the Health Service Executive in the University College/Merlin Park Regional Hospitals, Galway. In the event that the holder of the Personal Professorship ceases to hold the said office of Consultant of Emergency Medicine, (s)he shall thereby be deemed to have resigned from the said Personal Professorship.
3. The holder of the said Personal Professorship shall devote 24% of his/her time to the duties of the said Personal Professorship and 76% of his/her time to the duties of the foregoing office of Consultant of Emergency Medicine.
4. The annual stipend attaching to the said Personal Professorship shall be the salary attaching from time to time to joint fulltime Academic Medical Consultant Associate Professor appointments. It shall be payable in its entirety by the Health Service Executive.
5. The holder of the said Personal Professorship shall deliver clinical instruction to the students of the University at such hours and in such hospitals as the Academic Council may prescribe, subject to review by Údarás na hOllscoile.
6. The said Personal Professorship shall be a pensionable office in accordance with the relevant pension scheme provisions operated by the Health Service Executive in respect of Academic Medical Consultant Associate Professorships. The pension shall be payable in its entirety by the Health Service Executive.
7. Subject to the terms of the Employment Control Framework currently in operation in the Health Service Executive under direction from the Department of Health, or as such terms may be amended hereafter, the holder of the said Personal Professorship shall, subject to good conduct and the due fulfilment of his/her duties, be entitled to continue in office until (s)he shall have attained the age of sixty-five years, and may thereafter be continued in office for five further years : PROVIDED that such further continuance in office be recommended to Údarás na hOllscoile by the President and be sanctioned annually by Údarás na hOllscoile, and PROVIDED further that, in the case of an appointee who is deemed to be a “new entrant” to the public service in accordance with the provisions of the Public Service Superannuation (Miscellaneous Provisions) Act 2004, a holder of the said Personal Professorship shall not be entitled to retire before attaining the age of sixty-five years and shall not be obliged to retire on the grounds of having attained the age of sixty-five years.

8. The holder of the said Personal Professorship shall carry out the duties of the Personal Professorship under the direction of such Head of School as Údarás na hOllscoile shall from time to time deem appropriate.

CHAPTER II

1. There is hereby established in the University the following Personal Professorship:

Personal Professorship of Rheumatology.

2. The holder of the foregoing Personal Professorship shall be required to be at the same time the holder in a permanent capacity of the office of Consultant Rheumatologist to be established in conjunction with the said Personal Professorship by the Health Service Executive in the University College/Merlin Park Regional Hospitals, Galway. In the event that the holder of the Personal Professorship ceases to hold the said office of Consultant Rheumatologist, (s)he shall thereby be deemed to have resigned from the said Personal Professorship.
3. The holder of the said Personal Professorship shall devote 24% of his/her time to the duties of the said Personal Professorship and 76% of his/her time to the duties of the foregoing office of Consultant Rheumatologist.
4. The annual stipend attaching to the said Personal Professorship shall be the salary attaching from time to time to joint fulltime Academic Medical Consultant Associate Professorship appointments. It shall be payable in its entirety by the Health Service Executive.
5. The holder of the said Personal Professorship shall deliver clinical instruction to the students of the University at such hours and in such hospitals as the Academic Council may prescribe, subject to review by Údarás na hOllscoile.

Academic Medical Consultant Senior Lectureships. The pension shall be payable in its entirety by the Health Service Executive.

7.
